- Passport bio-data page (Front Page & ast Page).
- Confirmed return flight ficket.
- Birth certificate for minor applicants.
- Bank Statement for the last 3 months.
- Accomodation Detail (Hotel Reservation)
- Cover Letter (Visa Request Letter / Sponsor Letter / Company Cover Letter.
- Other documentation depending on applicants country.

Documents required to upload for eVISA

for Students or Expatriates.

- Visa Approval Letter (eVAL)
- Passport bio-data page (Front Page & Last Page)
- Confirmed return flight ticket.

Travel to Malaysia

- Upon arrival, the printed eVISA is required to be presented
- eVISA can be verified at all Malaysia Immigration air, land and sea checkpoints.

Visa Application at One Stop Centre (OSC)

OSC Submission Process Flow

- Agents / applicants are required to submit their application at OSC with all the following documents:
- 1. Application Form
- 2. Photograph
- 3. Current and if any Previous Passport
- 4. Request Letter from the applicant (Typed)
- 5. Proof of employment
- 6. Invitation / Sponsorship
- 7. Travel Itinerary (Return Flight Booking)
- 8. Accomodation Detail (Hotel Reservation)
- 9. For fresh passport holder

(Travelers Cheque or bank confirming the issuance of USD 500)

10. Bank statement for the last 3 months

(Original and Copy only in A4 size)

11. Marriage certificate / Birth Certificate

(In English Translation)

12. No objection letter

Important notification:

Hand written Passport is not acceptable.

Please ensure to have three complete blank pages in the passport for the purpose of visa stamping and approval. For all categories of Visa.

Visas can be categorized in two broad categories namely:

VTR (For tourist and business purpose)

Visa without reference is visa approved by the High Commission of Malaysia for social, tourist or business visits.

VDR (For students, expatriates, and workers)

Visa with reference is approved by the Department of Immigration Malaysia or the Ministry of Home Affairs for the purpose of working, studying or social visits for a stay more than the allowed period under visa without reference.
